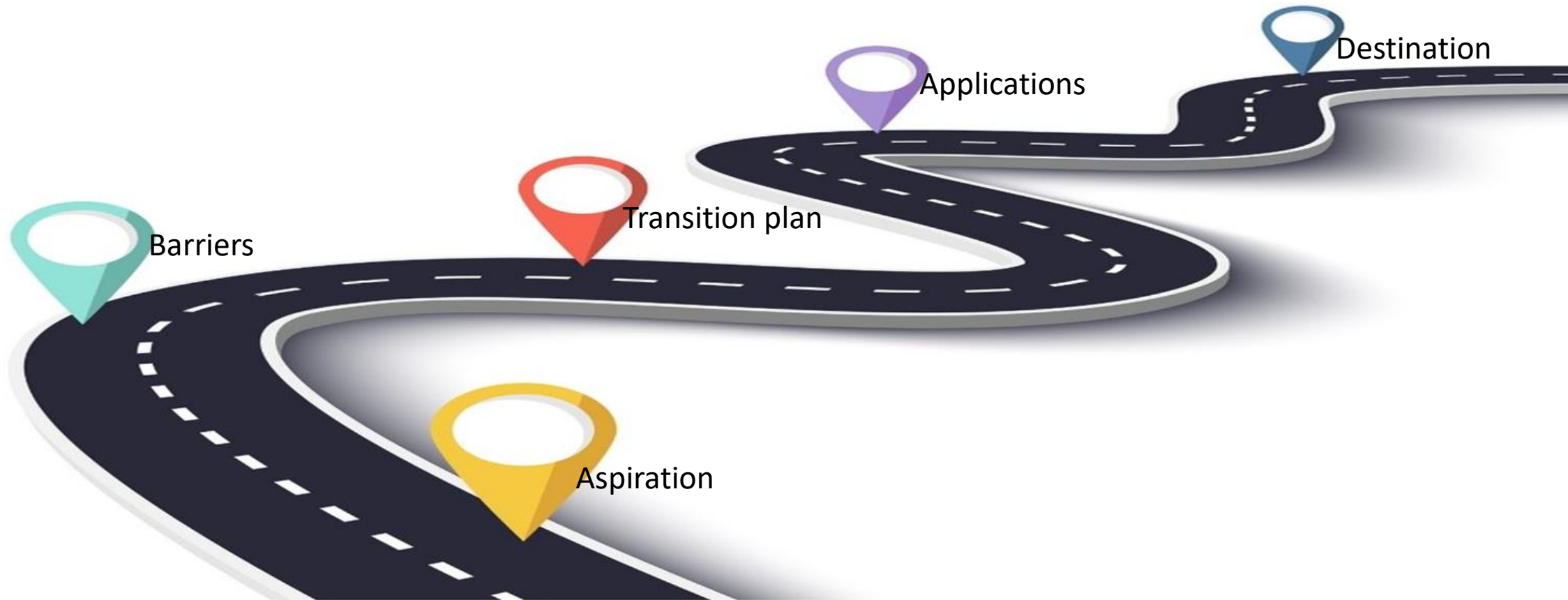

Guidance Advisers - what we do

- ❖ Guidance Advisers can offer information, advice and guidance to NEET young people
 - At Risk of NEET yr11 leavers (16yrs) to 18 yr olds
(3 x GA, 3 x SEND GA, 1.5 x Care Experienced GA)
- ❖ SEND Advisers offer support to NEET 16 to 25-year-olds who have EHCPs (over 19s who wish to continue in further education or training)
- ❖ Advisers offer a countywide service to 16–18-year-olds who are NEET and who need support to progress into Further Education, Employment or Training
 - NEET meaning Not in Education, Employment or Training

What can young people do post 16?

- Study full time at a sixth form, FE college or post-16 provider. The definition of full-time participation is at least 540 hours a year. Courses vary from Entry Level to higher Level qualifications in line with young people's aspirations, needs and learning level.
- Apprenticeship or a supported internship
- Full-time employment which should be combined with part-time study or training, as per RPA.
- Re-engagement/Volunteering - eg. King's Trust, BOOST, On Track, Positive Activities

Qualification Level	Examples	Description
Entry Level 1	Entry Level Certificate (ELC)	Basic knowledge and skills, suitable for beginners.
Entry Level 2	Entry Level Certificate (ELC)	Slightly more advanced than Entry Level 1, still foundational.
Entry Level 3	Entry Level Certificate (ELC)	The highest of the Entry Levels, preparing for Level 1 qualifications.
Level 1	GCSE (grades 3, 2, 1 or D, E, F, G), Level 1 Award	Foundation level, equivalent to lower GCSE grades.
Level 2	GCSE (grades 9, 8, 7, 6, 5, 4 or A*, A, B, C)	Intermediate level, equivalent to higher GCSE grades.
Level 3	A Levels, International Baccalaureate, T Levels	Advanced level, suitable for higher education entry.

Guidance Adviser for NEET CiC

- If a young person is NEET and Looked After by Norfolk County Council, each term we offer a NEET Casework Meeting to discuss their education, employment and training options. It is during these meetings that we complete the young person's NEET PEP.
- As the Guidance Adviser for NEET CiC I am responsible for coordinating these NEET Casework meetings.
- I work closely with the virtual school team to ensure that NEET Care Experienced young people are supported to engage with their EET options.
- I can meet with young people where their lead professional thinks this would be beneficial and offer careers guidance.

How to book a Consultation with an adviser and what support can be offered

If you wish to request advice from a Guidance Adviser/SEND Guidance Adviser on behalf of a NEET young person, please email helpyouchoose@norfolk.gov.uk with the following information:

- name of young person
- date of birth
- brief description of reasons for request for consultation

Once a consultation request has been received, a Guidance Adviser will get in touch with you to arrange a Teams meeting. This will be an opportunity to discuss the young person in question, explore options and identify next steps.

The adviser can provide you with up-to-date information/flyers/action plan/contact details/ways to refer, etc to help you to support your NEET young person

SEND Guidance Advisers

- Can offer advice and guidance through consultation with the allocated professional – rather than supporting the young person directly
- Can contribute to EHCP review meetings or multiagency meetings, or may be able to join the allocated worker for a call/virtual meeting with a young person
- Can advise on alternative options for young people with SEND who need bespoke or specialist provision, as well as options in mainstream settings
- Where placements have broken down or not been suitable for a young person due to the complexity of their needs, SEND GAs work closely with other professionals to identify opportunities that may enable a young person to engage and participate
